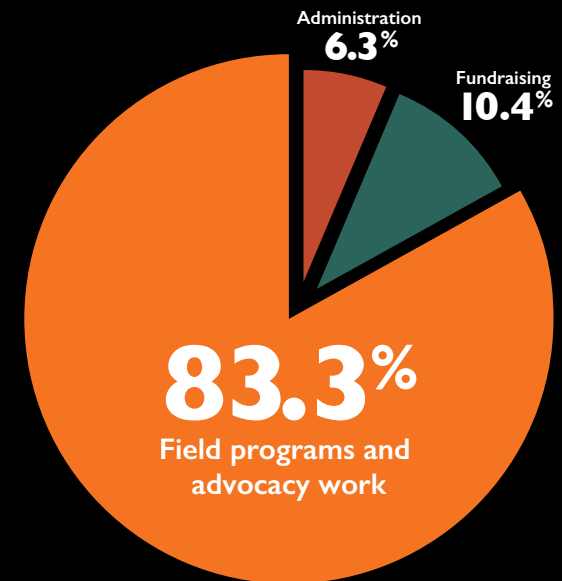
None of this work would be possible without the generous, ongoing support of compassionate Australians like you who share our vision for a world where all children thrive.

## **A journey leading to a legacy**

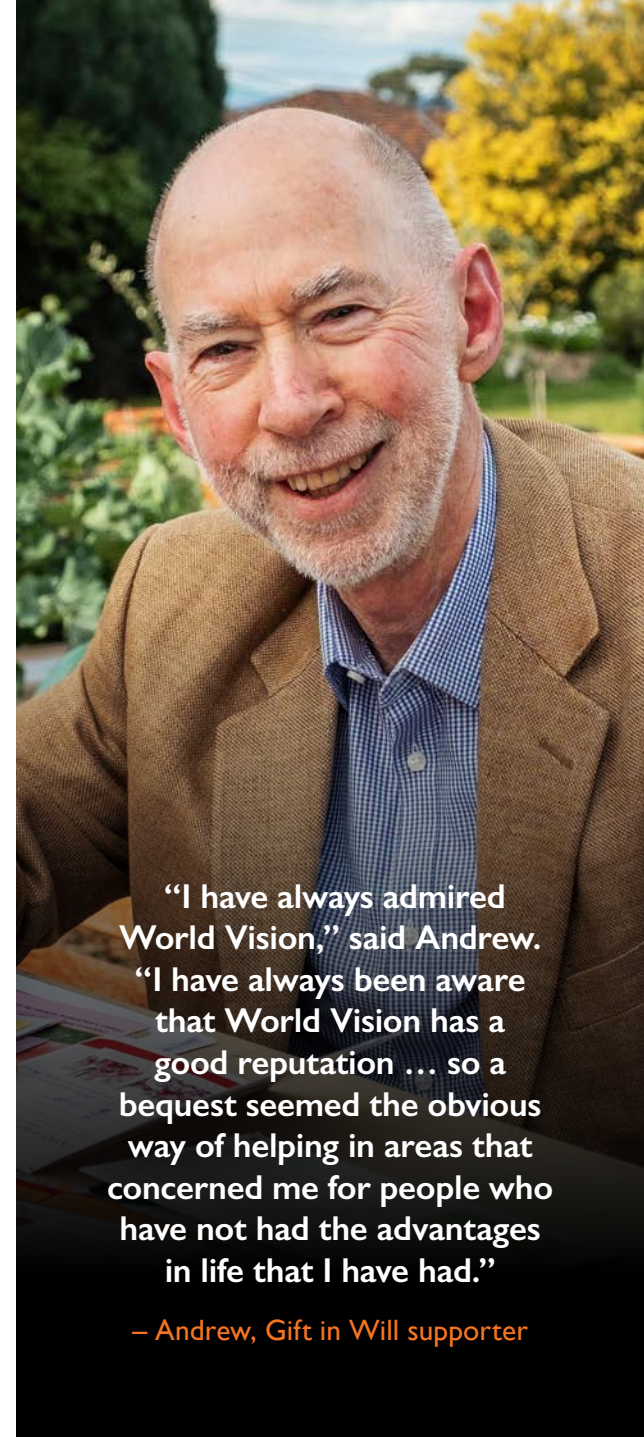
